**ARTS AND CRAFT INFORMATION
& Commercial Booth Information**

GROUND: Held in Bandera City Park on the Medina River.

ELIGIBILITY: Open to individual artists and craftsmen presenting their original works. No manufactured, imported or resale items will be allowed in the Arts and Craft area – only original works and prints by exhibiting artists. Demonstrating your art or craft, while not required, will be a consideration when booths are being assigned. Bandera Business Association reserves the right to reject any display that is not in keeping with the examples submitted. Commercial vendors are will be assigned spaces in the commercial area.

ALL VENDORS MUST APPLY FOR A CITY VENDOR PERMIT. To get permit, call 830-796-3765. Permits can be applied for by phone. We will pick up the actual permit and deliver it to your booth on Saturday. If you make your own products, there is no fee BUT YOU STILL MUST OBTAIN THE PERMIT. Resale permit is \$15.

YOU MUST APPLY BEFORE 5PM THE WEDNESDAY BEFORE THE EVENT

REGISTRATION: The registration fee is \$60 per space for the one-day show. There will be no price limit on your items sold and no commission will be taken. All registration forms must be accompanied by photographs sent to the event coordinator by e-mail or a link to your web site that shows photos of your work, and a check or money order payable to Bandera Business Association. **Your check will not be cashed until you have been accepted into the show. Deadline for application is June 22, 2018.**

SPACES: Open spaces *only* are provided and will be 10'x10'. You provide your own canopy. If you plan to use a canopy, tent, or umbrella, please specify and give dimensions. There will be a limited number of spaces available. Electricity will be available on a strictly limited basis at an additional charge of \$10 per space, and only to those *demonstrating* an art or craft.

NOTIFICATION OF ACCEPTANCE: Artists will be notified of their acceptance no later than June 24, 2019 by e-mail or phone. You will receive an information packet no later than June 26, 2019. *There will be no refunds after June 26, 2019 and no refunds should bad weather occur.*
